Patient Information

Your patch test results indicate that you have a contact allergy to hexyl cinnamic aldehyde. This contact allergy may cause your skin to react when it is exposed to this substance although it may take several days for the symptoms to appear. Typical symptoms include redness, swelling, itching, and fluid-filled blisters.

Where is hexyl cinnamic aldehyde found?

This substance is used in the creation and/or manufacturing of fragrance and flavor concentrates. Thus, it is found in perfumes, hair dyes and household products.

How can you avoid contact with hexyl cinnamic aldehyde?
